

## **MEMORANDUM of UNDERSTANDING (MoU)**

The below-mentioned organizations have signed this Memorandum of Understanding (MoU) on this day, the 17<sup>th</sup> Feb, 2023.

1. Mizoram Table Tennis Association (MTTA)
2. Govt. Aizawl College

### **I. AIMS AND OBJECTIVES OF MoU**

To promote and popularize Table Tennis game at the College level and to open up new avenues for students in playing and officiating Table Tennis game at the state, regional and international levels.

### **II. DUTIES AND RESPONSIBILITIES**

For the effective functioning of this MoU, the duties and responsibilities of both parties are laid down below:

#### **A. Mizoram Table Tennis Association:**

- i) MTTA shall try to arrange Table Tennis Board for the college students at the GAC campus.
- ii) MTTA shall provide Table Tennis Coach for GAC College students. The fees of hiring TT Coach will be borne by both parties in the ratio of 60:40 (GAC– 60% and MTTA 40%).
- iii) The fees for hiring a coach shall be fixed at Rs. 15,000 per month.
- iv) MTTA shall provide a Coach for each Semester and the duration for coaching shall be 1(one) a month per Semester.
- v) Coaching schedule, timing, and duration shall be as mutually decided by the Coach and GAC Sport Committee.
- vi) MTTA shall organize at least 1(one) Umpire Clinic/Technical Official Training Course for GAC students at least once a Year.
- vii) During College admission, MTTA will inform the District Table Tennis Associations and players of the possibilities of College admission through Sports Quota and ensure that GAC recruits the top talents in the State.

#### **B. Govt. Aizawl College:**

- i) GAC shall provide a Table Tennis room on the College campus.
- ii) GAC shall organize Table Tennis Coaching programme for students in consultation with MTTA.
- iii) GAC shall take initiative for the formation of a GAC Table Tennis Club, which will be registered under the Aizawl South Table Tennis Association.
- iv) During the tenure of this MoU, the GAC TT Club shall attempt to participate in at least 1(one) Table Tennis Tournament organized by the Mizoram Table Tennis Association.
- v) GAC shall ensure that their students participate in Umpire Clinic/Technical Official Training Course organized by the Mizoram Table Tennis Association.
- vi) GAC students who have attended Umpire Clinic/Technical Official Course shall officiate in every Table Tennis Tournament organized by the Mizoram Table Tennis Association and they shall be reimbursed at the rate of Rs. 800 per head daily.

vii) At the time of College admission, State Top Ranked Table Tennis players who are officially endorsed by MTTA will be given preference through sports quota.

### **III. TENURE OF THE MoU:**

The tenure of this MoU shall be valid from the date of signing this agreement till the end of March 2024 which may be reviewed and extended for another period if both parties agreed to do so. Any of the parties could terminate this MoU by submission of a letter of termination 30 days in advance to the other party.

If any issue arises which is not covered by the above-mentioned points, representatives of both parties shall decide the matter accordingly.

We, the undersigned, as an affirmation of mutual consent and agreement on the above-mentioned points, hereby give our signature on this Memorandum of Understanding(MoU) on this day, the 17<sup>th</sup> Feb, 2023.
